BUSINESS TRANSFER, ACCOUNTING BS - ASSOCIATE IN ARTS (RIC)

This program constitutes a JAA transfer program to RIC. Students completing a JAA plan receive an Associate's degree and enter the receiving institution with 60 credits and Junior status. Students must complete all requirements as given. Depending on GPA, students receive a tuition discount of up to 30% at the receiving institution, a waived application fee, and personalized advising.

This program provides students with a solid foundation in financial and managerial accounting, business communication, and office technology, preparing students for advanced study at RIC. The program emphasizes a foundation in accounting, communication skills, and a foundation in business areas including management and marketing. Through this seamless transfer pathway, students can complete their associate degree at CCRI and advance into RIC's nationally recognized accounting program with junior standing.

Program Learning Outcomes

Upon completion of this program, a student will be able to:

- 1. Create written work that develops and expresses ideas and that addresses a given context and target audience.
- Communicate effectively via oral presentations, performances, participation in group work, and visual presentations.
- 3. Identify, analyze, and apply evidence and ideas, question assumptions, and draw logical conclusions.
