PALG The Paralegal Studies Degree Program is currently suspended and not accepting new students.

The Community College of Rhode Island offers a degree program for individuals interested in a career as a legal assistant. Graduates of the program have the option of entering the workforce as a trained paralegal or continuing their education by transferring to a college offering a bachelor's degree program in paralegal studies.

Paralegal portfolio requirement: For students enrolling in the Paralegal major, the completion of a portfolio of their coursework will be required near the end of their course of study. Students will prepare the portfolio as part of either Basic Civil Procedures for Paralegals (LAWS 2020) or Legal Research and Writing (LAWS 2090), whichever one of these two courses they take last.
